YAC staff are determined to provide help with protecting and maintaining Country, history, heritage and culture.

Yinhawangka sends their deepest condolences to all members of Yinhawangka that have lost a loved one and sends comfort for those that are still grieving.



CHAIRPERSON'S REPORT

I'm very fortunate and humbled to provide another chairperson's report for the mob. I'm grateful and appreciative of the YAC Board for reelecting myself as the Chairperson during a time that was and still is challenging for the Yinhawangka Aboriginal Corporation, the membership, and stakeholders. It has been my mission to encourage, support and listen to the board on their opinions, understanding their visions and guiding YAC to prosperous pathways.

As the Chair I've encouraged the YAC Board to develop a Strategic Plan collectively with the Yinhawangka Council and the Decision-Making Committee (DMC) with hopes to protect, persevere and keep Yinhawangka healthy, proud, and strong. As Yinhawangka develops, the PBC is now equipped with a clear vision from the membership and now obligated to help Yinhawangka stay Healthy, stand Strong with Culture, Spirit and Determination. We as the Board of the PBC feel this vision will create growth and prosperity for Land, Culture, Heritage, Education, economic and enterprise development providing the membership with healthy and beneficial outcomes. As Traditional Owner and chair of the PBC, I was invited to speak on behalf of Yinhawangka pushing an agenda that will benefit Culture, Heritage, and Language of Yinhawangka, then reaching out to the government, businesses and other Traditional Owner groups for opportunities and solutions on working together. The conference provided a forum to deliberate and communicate on-country opportunities, piquing my interest for possible partnerships and understanding of other entities objectives in supporting healthy country and its Traditional Owners.

The representation and involvement of young emerging leaders at the RIC was impressive, witnessing a productive collaboration between youth and Elders is something I would like reflected in YAC's Board and the Trust DMC and Council.

Since the destruction of Juukan Gorge, the nation has reframed their attention to the Pilbara as evident at the RIC, with concerns of surrounding Traditional Owners resulting in heavy scrutiny of mining companies. Yinhawangka must do better as a neighbouring tribe, we must support the Puutu Kunti and Pinikura People by changing how Yinhawangka is approached. Our opinions are vaild, and our voices demand to be heard.

YINHAWANGKA RANGER PROGRAM





The Rangers have stayed connected with country despite COVID-19, still conserving country, history, heritage, and culture. Rangers had multiple opportunities to travel and to attended conferences throughout the year, equipping themselves with new methods and ideas to implement on Yinhawangka Country. Partnerships and joint venture relationships are increasing, providing more exposure and opportunity to the Yinhawankga Rangers such as the Angelo River Vertebrate Fauna Survey and the Biodiversity Conference on Noongar Country (Perth).

Pilbara Cultural Land Management Program (PCLMP)

A week-long Workshop in Port Hedland in September 2021 focused on land management planning that supports strong cultural, environmental, and economic futures. The purpose was to help Pilbara Ranger groups come together and share knowledge of the cultural, environmental, and economic land uses already in place on their county and explore future scopes and funding and resourcing opportunities through the guidance and support of the PCLMP partnerships. The workshop also provided a training element which gave basic fulcrum use of Google Earth software in pattern monitoring using unmanned piloted aircraft (Drones), an area which the YAC Rangers are well advanced in terms of its drone program objectives. Our Rangers routinely use drones for data collection, heritage recording and monitoring for changes over time at Important Sites for Yinhawangka.

RANGER NEWS

Birduwarli (Palm Springs) Rockfall



Sometime in late May 2021, it was noticed that a rockfall had occurred approximately 100 metres from the entry to Birduwarli. Photographs and drone footage were taken to assist with determining the cause and scale of impact at the site in the first week of June 2021.

It does not appear any rock art images were on the fallen rocks. The cause of the rockfall appears to have been water seepage from recent rainfalls which loosened the boulders resulting in its collapse. YAC will be investigating further however.

The track to Birduwarli has 'Closed Road' signs placed across the access track and before the access gate due to it being a public health hazard area. Members can still access the site for cultural purposes, by calling Hilton for the access code.

Despite setbacks from COVID-19 the Yinhawangka Rangers are determined to keep Yinhawangka Country healthy; constantly out monitoring and maintaining flora, fauna, and waters. The team are excited for country to see the rivers flowing, animals active and plants revived.



RANGER UPDATE

Devina Ranger & Kalwin Dann - Yinhawangka Rangers

Kalwin Dann and I attended the Biodiversity Conference held in Perth at UWA from the 15th to the 17th of September 2021. Over the duration of the three-day conference, we got to network and meet different people from Noongar Country, the Kimberley and to also catch-up with familiar faces from the Pilbara.

Professor Stephen Van Leeuwin is an Aboriginal Noongar Professor in Biodiversity & Environmental Science at Curtin University, a leader in both his Noongar community and professional community. As one of the keynote speakers at the Biodiversity Conference, he spoke about the Indigenous Stewardship which consisted of Indigenous Estate, Indigenous Conservation Estate, Indigenous Land and Sea Managers and working with Indigenous Land and Sea Managers.

My highlight is my new found appreciation to the Rangers from the Kimberley, East Pilbara and Mutawa in the Murchison area who gave presentations on the first day about Flora & introduced Fauna, pattern burns and how to connect Indigenous knowledge and science with Aboriginal Peoples. Learning what the other Ranger Groups were doing to protect their land, was very inspiring and I have equipped myself with their knowledge and the way they conduct their Ranger programs onboard and hope to use some of the methods as soon as our own Yinhawangka Ranger group expands.

Attending the conference has reinforced our determination to help heal, protect, and preserve country as Yinhawangka Rangers.

HERITAGE

Dr Anna Fagan - General Manager ~ Heritage Operations

The Heritage department of Yinhawangka Aboriginal Corporation has had to jump through many hurdles this year, shifting from surveys, excavations, important meetings, legal and Native Title battles, and workshops and training with mob. Nonetheless, even though it was a tough year, the team has had huge achievements and is heading in the right direction.

Heritage concerns turned sour however with the new Aboriginal Cultural Heritage Act Bill 2021. Yinhawangka Aboriginal Corporation staff and Traditional Owners and other Western Australian Traditional Owners marched on parliament in protest over the fact that the new Bill favours the mining industry, while providing no support to PBCs, and fails to protect Country.

To build capacity for the PBC, YAC has been supporting staff and Traditional Owners to attend workshops, training, conferences, and summits, to learn, connect and promote Yinhawangka Culture. YAC and Yinhawangka networked and learnt a great deal at the Pilbara Futures Summit and the AIATSIS Summit in Adelaide.

The Pilbara Summit on Noongar Country in Perth equipped YAC and Yinhawangka to better understand and plan for economic growth after mining for self-determination, financial prosperity, while maintaining cultural and ecological resilience and sustainability. With these new ideas and initiatives YAC can successfully negotiate with stakeholders to propose potential joint venture partnerships in profitable and culturally sustainable economic projects.

Yinhawangka Traditional Owners and YAC staff also attended the AIATSIS conference in Adelaide. This provided a powerful educational forum for Aboriginal People, academics, government, native title, legal experts, and community sectors to yarn about addressing critical and emerging challenges. Yinhawangka returned home armed with more knowledge, network connections, and new and exciting ongoing projects that will be hugely beneficial for the growth of Yinhawangka Aboriginal Corporation and the membership.

SURVEY UPDATE

Surveys have had to keep to a strict timeline to complete all the required fieldwork in 2021 and 2022 in order to progress heritage work and Social Surroundings for West Angelas and the Western Range, while being sensitive of and accounting for many meetings, Sorry Business, and COVID restrictions.

Three trips were allocated to carry out the Social Surroundings fieldwork, where Traditional Owners travelled on Country throughout West Angelas and Western Range while considering Rio Tinto's mining proposals and developments. The Yinhawangka TOs yarned about significant places and potential impacts to Country, educating Rio Tinto representatives on Yinhawangka knowledge, stories, and connection to Country.

Once all Social Surroundings fieldwork and legal management documents for these proposals have been completed, Yinhawangka People will come together to collaborate on alternative solutions for the Greater Paraburdoo and West Angelas mines in order to better protect Country. As always, the team are identifying ever more heritage sites that need to be understood and protected. A very big thank you to all members who have participated in surveys.

Social Surroundings is a revolutionary fieldwork and research project and legal document. It has been designed and driven by Yinhawangka People and Country to identify and reduce short and long term impacts to Country and social, cultural, spiritual, and economic values and propose new management actions and commitments for mining companies and State government.

GIS UPDATE



Renee Manser - GIS Officer

YAC is currently developing and implementing exciting new mapping software and database management system for YAC and the Yinhawangka membership to use. This web-based application will allow YAC and Yinhawangka to view and understand landscape changes and vegetation growth over time, identify areas of ground disturbance from mining operations and exploration and pastoral activities, and to help identify undocumented archaeological places.

Yinhawangka Traditional Owners will have access to history, knowledge, and cultural information as well as ranger program activities, heritage survey updates and outcomes, and cultural activities.

This data management system will provide secure access to staff and members with all the appropriate cultural and gender restrictions and permissions. The program will enable and encourage Yinhawangka membership to help update and upload crucial information about Country, to better protect Yinhawangka Lands and support the PBC and the Yinhawangka Rangers to keep Country strong. YAC hopes to bring the final application to the PBC and membership by early 2022.

REGISTER UPDATE

In November 2021, YAC Board of Directors approved engagement of Microsoft based program ATMS (Aboriginal Trust Management System) for the PBC Member Management. The implementation of this program brings the PBC in line with other Corporations to effectively manage the record keeping of the Register of Yinhawangka People and Register of Members, now and into the future.

With Phase 1 nearing completion, we are looking to streamline the Membership Application processing through management in ATMS, also working towards updating the YAC Membership Kit to be more user friendly and accessible to joining members everywhere through print and online access.












YINHAWANGKA NATIVE TITLE CLAIM AREA
