



## EXPRESSION OF INTEREST

### YINHAWANGKA DIRECTOR NOMINATION

**Yinhawangka Aboriginal Corporation (YAC) is seeking Expressions of Interest for the nominations of 3 Directors, for election at the 2024 Annual General Meeting (AGM)**

#### **Background:**

The YAC Board has determined that Directors should be elected through a strong governance process, bearing in mind the increasing complexity of YAC's business and the large scope of YAC's functions and activities. An important part of the process is ensuring before the AGM that YAC director candidates are eligible to be elected.

YAC has 3 director appointments at the upcoming AGM with one director from each Apical group Minatangunha, Jardhunha and Thurantajinha & Wilga. These positions will be for a term of 2 years.

YAC are looking for committed and dedicated leaders to step up and become part of the dynamic board that is responsive and adaptable, to help meet current requirements and to also prepare YAC for the future.

#### **Meetings & duties:**

Directors have a vitally important role in overseeing YAC and must be committed to complying with the duties imposed by law and to act in the best interests of YAC, at all times. Directors are expected to participate in ongoing training about their responsibilities as directors.

Directors have an obligation to prepare for, attend and actively participate in all meetings, including monthly board meetings, regular committee meetings, and other meetings from time to time. Board meetings can be conducted in Paraburdoo and Perth, or other locations.

#### **Eligibility:**

In order to be eligible, applicants must be a member of YAC and a Yinhawangka person and meet the requirements outlined in Rule 9.3 of the YAC Rule Book. A copy of these requirements is set out below. Directors will also need to provide a Director Identification Number which is an Australian Government requirement.

Please also note, if you are confirmed as eligible, then within 14 days and prior to commencement as a Director, you need to provide:

- a current (within last 12 months) Police Clearance certificate; and
- Director ID, from the Australian Business Registry Services.

## How to apply

To express your interest in becoming a YAC Director please complete the following forms:

1. **Nomination form**
2. **Consent to Act form**

After receiving your application YAC will consider and determine whether you are eligible to be elected as a YAC Director. YAC will communicate this to you before the AGM.

Some of the information you provide in your Nomination Form will be included in a summary for the members at the AGM (e.g. why you wish to be a director). This is intended to help the members decide on the best candidates for YAC.

## Extract of the YAC Rule Book Section 9.3

### Eligibility for appointment as a YAC Director

#### 9.3 Eligibility of directors

A director (other than a director appointed under rule 9.7) must be:

- At least 18 years old
- A member
- A Yinhawangka person
- Consent in writing before being appointed as a director.

A person is not eligible to become a director if the person:

- Has been disqualified from managing corporations; or
- Is a full-time employee of the corporation; or
- Is currently serving a term of imprisonment of three months or more.

1. have been convicted of an offence under the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* (CATSI Act) that is punishable by imprisonment for more than 12 months;
2. have been convicted of an offence involving dishonesty that is punishable by imprisonment for at least three months;
3. have been convicted of an offence against the law of a foreign country that is punishable by imprisonment for more than 12 months;
4. am an undischarged bankrupt;
5. have signed a personal insolvency agreement and have not kept to the agreement; or
6. have been disqualified under the *Corporations Act 2001* from managing corporations;

and I will notify the corporation if any of the above events occur after my appointment within a reasonable time.
